Tuesday, November 5, 2024 - Run-Off Election **(if needed)**

QUALIFYING PERIOD: MONDAY, JUNE 10, 2024 AT NOON THROUGH FRIDAY, JUNE 14, 2024 AT NOON - ALL QUALIFYING PAPERS & FEES MUST BE SUBMITTED TO THE CITY CLERK BEFORE NOON ON FRIDAY

- 1) MAYOR - 4 YEAR TERM *(limited to 2 consecutive terms)*
